## Defined *obscenity*

- ✓ An “average person” using “contemporary community standards” considers it prurient
- ✓ It “depicts or describes” patently offensive sexual material
- ✓ Lacks serious “literary, artistic, political or scientific value”

## Writer Arrested After Sending Violent Fiction Over Internet

By PETER H. LEWIS

A University of Michigan student who was jailed after publishing a sexually violent work of fiction about a classmate on the global Internet computer network was denied bail yesterday.

Magistrate Thomas A. Carlson of Federal District Court in Detroit said that although the student, 20-year-old Abraham Jacob Alkhabaz, who uses the name Jake Baker, had never physically approached or spoken with the classmate, the writing suggested that Mr. Baker was "disturbed" and "dangerous," and that he was "a ticking time bomb waiting to go off."

Mr. Baker, a sophomore from Boardman, Ohio, was arrested in

stuff," and that he had never spoken to the woman whose name he used.

The Michigan Daily newspaper reported that Mr. Baker's story involved "torturing a woman with a hot curling iron, and mutilating and sodomizing her while she is gagged to a chair."

A University of Michigan alumnus in Moscow was browsing alt.sex.stories in Russia, saw the story, noted its origin and alerted school officials. Campus police and Federal agents were asked to investigate.

In an affidavit, an F.B.I. agent, Greg Stejskal, said that in addition to filing his story Mr. Baker had an electronic exchange of messages with subscribers to alt.sex.stories in

From “Grandstaff”:

“She’s shaking with terror as Jerry and I circle her. She’s almost completely nude now ... Jerry and I snap pictures of her tiny trembling body from all angles.

Jerry grabbed a handful of her hair and pulled her face up ... Her eyes, barely human, begged him to stop. He laughed aloud and gave her a firm smack. Her head jerked sideways ...

“C’mon, man, let’s go.” ... So we got the gasoline and spread it all over Erin Grandstaff’s apartment. We chucked it over her. It must have burned like hell when it came into contact with her open cuts ...

“Goodbye, Erin” I said, [&] lit a match...

Baker to “Arthur Gonda” (12/94):

“I’ve started ... going back and re-reading earlier messages of yours.

Each time I do, they turn me on more and more. I can’t wait to see you in person. I’ve been trying to think of secluded spots, but my area knowledge of Ann Arbor is mostly limited to the campus. I don’t want any blood in my room, though I have come upon an excellent method to abduct a bitch ...

As I said before, my room is right across from the girl's bathroom. Wait until late at night, grab her when she goes to unlock the door. Knock her unconscious and put her into one of those portable lockers (forgot the word for it), or even a duffle bag. Then hurry her out to the car and take her away ... what do you think?"

“Arthur Gonda” replies:

“Hi Jake. I have been out tonight and I can tell you that I am thinking more and more about ‘doing’ a girl. I can picture it so well ... and I can think of no better use for their flesh. I HAVE to make a bitch suffer!”

Baker to Gonda:

“I highly agree with the type of woman you like to hurt. You seem to have the same tastes I have. When you come down, this’ll be fun!

Also, I’ve been thinking. I want to do it to a really young girl first. 13 or 14. Their innocence makes them so much more fun and they’ll be easier to control. What do you think?”

Gonda replies to Baker:

“I would love to do a 13 or 14 year old. I think you are right. Not only their innocence but their young bodies would really be fun to hurt. As far as being easier to control... you may be right, however you can control any bitch with rope and a gag. Once they are tied up and struggling we could do anything we want to them... to any girl. ... BTW how about your neighbour at home?”

Baker replies to Gonda:

“True. But young girls still turn me on more. Likely to be nice and tight.

Oh. They’d scream nicely too!

Yeah. I didn’t see her last time I was home. She might have moved. But she’d be a great catch. She’s real pretty. With nice long legs and a great girly face ... I’d love to make her cry ...”



Baker to Gonda:  
“Just thinking about it anymore



